- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

We are currently endeavouring to apply these systems across the entirety of Cognita at the School level.

SUPPLIER ADHERENCE TO OUR VALUES

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we require all our suppliers to sign our contracts and agreement which incorporate compliance with the Modern Slavery Act 2015.
